

STEPS FOR SENDING ONLINE ADMISSION FORM

Download the admission form for the year 2024-25 from the link,

<https://www.vsisugar.com/admissions>

- 1) Get a print copy of the **ADMISSION FORM 2024-25**.
- 2) Fill the admission form by blue pen neatly in **CAPITAL LETTERS**. Incomplete form will not be accepted. Reply will be given on second day after receipt of form. You have to send corrected form again, if any.
- 3) All detailed information is mandatory. (*Nomination form is not mandatory for M.Sc. EVSC and M.Sc. WBAT courses*).
- 4) Nomination form is mandatory for SBC, SMC, SEC, ST, SED, IFAT, SIT.
- 5) Admission form fee of Rs. 500/- is to be transferred online to the following :

- 9) Scan the following,
 - a. Filled admission form with photos (4 pages).
 - b. Nomination Form with duly signed and stamped by Factory Authority.
 - c. Educational testimonials (transcript and certificates from 10th to eligible degree level).
 - d. Affidavit of Gap Certificate (if gap in education).
 - e. Details of payment of Rs. 500/- towards admission form fee. (screen shot of payment with UTR No.)
- 10) Create a single PDF file of all the scanned documents and send to the e-mail id : vsiadmissionform@gmail.com (send the form only one time).
- 11) It should be noted that at the time of entrance test/interview/admission, provision of original documents for verification is mandatory.
